

PA is requested to provide complete information specially dates of constitution of committees, boards, transfer policy and transfer orders, powers and duties of employees, work allocation, FAQs, redressal of grievances, budget, subsidy, RTI related committees, tenders and PPP information in order to comply CIC directions.
    - iv.) The information in vernacular language is also not available on the website so please provide it.
    - v.) The information should be provided with suitable links as same links have been provided for multiple information at different places.
    - vi.) Action should be taken for STQC certification for the Website of Pasteur Institute of India, Conoor, Tamil Nadu.
